

Founded in 2010, the Byron Bay Surf Festival (BBSF) is operated by Byron Bay Surf Festival Pty Ltd (ABN:68153063319) in partnership with Surfers for Climate (ABN:83642508781). It showcases core and creative surf culture by presenting innovative and experiential ideas through unique and engaging experiences. The 2024 BBSF hosted approximately 82 unique surfers and contest attendees across three days of surfing events.

The Festival inspired several events including surfing, art, music, film, special guests, and environmental aspects with an awareness and focus on sustainability, education, and innovation. These cultural events attracted over 4600 attendees.

BBSF is proud to be a sustainable event and has a clear path towards reducing environmental and community impacts through education with a curated festival of like-minded vendors and special guests.

Last year BBSF was proud to be the first surf event in Australia to certify carbon neutral with Climate Active. BBSF 2024 is carbon neutral for the surfing events, which include emission activities (attendee travel, accommodation, waste, water, food, products, professional services, ICT services and equipment and stationary fuels.) BBSF cultural events, outside its control, are excluded from this reporting. "Our mission is to celebrate surfing as a profound expression, art form and lifestyle."










All emission sources listed in the emissions boundary are part of the carbon neutral claim. Quantified emissions have been assessed as relevant. Those meeting only one condition of the relevance test can be excluded from the certification boundary. Emissions tested for relevance are detailed below against these criteria:

- 1. Size: The emissions from a source are likely large relative to the event's electricity.
- 2. Influence: The entity can influence emissions reduction from a source.
- 3. Risk: Emissions contribute to the event's greenhouse gas risk exposure.
- 4. Stakeholders: Key stakeholders deem the emissions relevant.

5. Outsourcing: Emissions are from outsourced activities previously or typically within the event's boundary for comparable events.

If emission sources have been non-quantified due to one of the following reasons: 1. Immaterial <1% for individual items and no more than 5% collectively 2. Cost effective Quantification is not cost effective relative to the size of the emission but uplift applied.

OUR ENVIRONMENTAL ACTION

Our sustainability policy focuses on three core areas: offsetting carbon emissions, minimising energy consumption and minimising waste.



01. Offsetting Carbon Emissions

•Calculate and offset the CO2e emissions from ticketed surfers' travel and event operations through Sea Trees, raising awareness of travel impacts on the environment. Measure and communicate the Event's activity carbon emission summary to educate attendees about CO2e, the event's main emission sources and how they can help reduce CO2 impacts.



02. Minimising Waste

We aim for minimal waste creation and divert over 75% of all waste from landfill. We reuse event equipment to minimise consumption and waste. Promote reusables to encourage plastic free. Provide waste options for: Landfill, Earn & Return (benefiting local NGOs), Organics (for composting) and Recycling. We conduct daily clean-ups at surfing event locations and advocate for the Take 3 for the Sea Byron, Balloon Free Byron Shire and Butt Free Byron Shire initiatives.



03. Minimising Energy Consumption

Whenever possible, minimise energy consumption for any emissions sources and continue the goal to source renewable energy sources to power Festival operations on the beach.







There are 17 <u>United Nations Sustainable Development Goals</u> and 169 targets in total. While they are all important and interrelated Byron Bay Surf Festival has a keen focus on #12 Responsible Consumption and Production, #3 Gender Equality and #13 Climate Action.



01. Responsible Consumption and Production

Ensure sustainable consumption and production patterns .Partnering with sustainable and eco-conscious surf brands allows us to be mindful and responsible in what we produce and consume for the Festival ensuring we focus on reusable and sustainable solutions.



02. Gender Equality

Achieve gender equality and empower all women and girls especially in surfing. In the 2024 BBSF we hosted the Women's Surf Aid Tag Team event and continue to push for equal opportunity for women to participate and win in all surfing events and competitions at BBSF.



03. Climate Action

•Partnering with Byron Bay's environmental protection agencies to promote local actions that safeguard our coastlines and marine life from pollution. We also offset all our carbon emissions to <u>SeaTrees</u> which aids in the restoration and protection of at-risk marine ecosystems.
